As per the directives of the Hon'ble Supreme Court, UGC Regulations on curbing Ragging in Higher Educational Institutions, 2009, The Haryana Prohibition of Ragging in Educational Institutions Ordinance, 2012 and AICTE Regulations 2009 on Prevention and Prohibition of Ragging in Technical Institutions Universities including Deemed to be universities imparting technical education, ragging within the premises of MRIIRS is a "grievous offence."

- Any individual student/group of students indulging in ragging, subject to the following acts, will be severely punished:
- Any spoken or written act of conduct that harms the reputation or the physical, financial or psychological condition of another student/students (teasing, mistreatment, rudeness, etc.)
- Indulging in unlawful and non-disciplinary misconduct that interferes with the orderly administration and official policies of the institution and which is likely to cause annoyance or hardship and/or raise fear of apprehension in the student subjected to such treatment.
- Compelling/Coercing a student to indulge in an act that may cause them to experience shame, torment, humiliation or embarrassment.
- Any act that prevents, disrupts or disturbs the regular academic performance of the student subjected to the act.
- Exploiting the services of a student to gain academic advantage and/or to complete academic tasks/projects.
- Any act of financial extortion or forceful burden of expenditure to be borne by the student subjected to the act.
- Any form of physical/psychological sexual abuse (homosexual/hetrosexual) assaults, forced stripping, forced performance of obscene acts, etc) causing harm to the student. subjected to the act.
- Any act of abuse/ sabotaging the reputation or mental peace of a student through emails, social media posts, public insults, printed material, etc.
- Any act of bullying or discrimination on the basis of colour, race, religion, gender, caste, sexual orientation, physical appearance, nationality, geographical or linguistic identity, family
- Punishment for acts not covered above that may cause harm to the physical/psychological/ economic condition of a student/students shall come under the discretion of the university disciplinary committee and shall be levied as and when required.
- Administrative actions (punishments) for students found indulgent in ragging:
- Subjected to a fine of up to 25 Thousand Rupees
- Cancellation of eligibility to sit in exams
- Suspension or expulsion from the institution
- Forfeiting of campus placements and academic privileges
- Relinquishing the right to represent the institution in any regional/state/national/international event/fest/tournament etc
- Withholding/withdrawing scholarships/fellowships and/or other financial aid
- Imprisonment by the Indian Law Enforcement Agency
- To curb the menace of ragging, MRIIRS has constituted an Anti-Ragging Committee to oversee the strict and meticulous implementation of the anti-ragging directives for the academic year 2024-2025. Any student subjected to ragging or coming across an act of ragging can immediately reach out to the committee members.
