## Glimpses of Activities Organized During the AY 2023-24

#### • Session on Equity through Gender Neutral Work Roles on August 21, 2023

School of Leadership and Management organised a Session on 21st August, 2023 in association with Gender Sensitising Cell on "Equity through Gender Neutral Work Roles". The session was conducted by Dr. Swati Punjani, Assistant Professor SLM-PG. The session began with an interactive activity where all the students were divided into teams and an occupation list was provided to them all to highlight as per the list- men's work or women's work. This was an exercise where students identified and analysed traditional gender roles in the workplace in two categories on the basis of Gender. The whole idea behind this exercise was to make them understand Gender Equity, Gender neutrality, Gender Parity and DEI. After the activity an open discussion was done with the students on why Gender designated jobs and how we can really move ahead of this and promote equity for all. The session focussed on developing independent thinking regarding standardised gender roles and develop a strategy to for promoting gender neutral roles and their acceptance in the society. A digital campaign was also run in the support of the above activity by posting on the issue on social media followed by likes and shares on the post.



#### • Session on Capacity Building workshop on "Importance of Gender Identity" at MRIIRS on August 29, 2023

The Gender Sensitize Cell of Department of Biotechnology SET MRIIRS conducted a capacity building workshop on the "Importance of Gender Identity" on 29th August 2023 at 10:300 hrs. at Block A, Third Floor, Room no.19. The workshop aimed to raise awareness about the significance of gender identity and equality in society and empower participants to become advocates for gender equity. The event brought together a diverse group of individuals, including students, faculties and helping staff to engage in discussions and activities related to this crucial topic (N=116). The primary objectives of the workshop were as follows:

 To educate participants about the concept of gender equality and its importance in fostering a just and inclusive society.
To highlight the various forms of gender discrimination and bias that exist in our society. The workshop featured an informative presentation, interactive discussions and quiz activity. Dr. Prabir Paul, HOD, Department of Biotechnology, SET MRIIRS addressed the students and discussed about the role and importance of Gender equality in professional and personal life. He emphasized on assessing and sharing the issues related to gender inequality with family members, faculty at MRIIRS for any kind of problems or issues related to gender discrimination. Dr. Vineeta Sharma, event coordinator (GSC-Cell) introduced Resource person: Dr. Jayant Maini (Assistant Professor, Biotech Department) to the students representing both male and female students. Dr. Jayant's presentation defined the gender equality and underscored its relevance in contemporary society. He discussed the Gender Stereotypes and Bias, Benefits of Gender Equality, Legal Frameworks and Policies and Empowerment Strategies.



## Session on Gender Sensitisation, 28 August 2023

This campaign, led by the UN Secretary-General and UN Women since 2008, aims to prevent and eliminate violence against women and girls around the world, calling for global action to increase awareness, promote advocacy and create opportunities for discussion on challenges and solutions. This year's activism program was to eliminate gender-based violence. To mark this important day, the Gender Sensitising Cell of MRIIRS in association with the School of Media Studies and Humanities, organised "Understanding the spectrum of gender-based violence: From microaggressions to physical abuse ", a conversation on gender-based violence and how it ranges from microaggressions, which are often overlooked, to physical abuse in order to understand the concept of gender identities, reflect on and organise thoughts and opinions on the issue and bring fresh perspectives on the same. Prof (Dr) Maithili Ganjoo, in conversation with Prof. (Dr) Gauri D. Chakraborty, Professor, Times School of Media and Chairperson, Women Development Cell, Dr Sushree Panigrahi, sociologist and researcher and Ms Privanka Dubey, investigative journalist and author of "No Nation for Women" discussed about the spectrum of violence, microaggressions and the increasing rate of crime and gender-based violence globally and also about what is the role of media in reporting such issues.

Following an official welcome address by Prof. (Dr) Maithili Ganjoo, Chairperson, Gender Sensitizing Cell, MRIIRS and Dean, School of Media Studies and Humanities, Dr. Ganjoo initiated the conversation by pointing out that a lot of understanding is required to create a society conducive to accepting gender identities.

While speaking about violence against women and gender-based violence, Ms. Priyanka Dubey said "There are insane levels of violence and none of us can deny that children and women are dying". Dr. Gauri Chakraborty spoke about "avoiding the vibhatsa" from the Navarasa (Natyashastra) point of view and talks about how violence, now-adays makes for a good story which sells and thereby is not avoided anymore. Dr. Chakraborty further speaks about the consumption of violence put in a platter by the media for the audience. She took examples of movies like "Thappar" which now acknowledge violence at a micro level. Dr. Sushree Panigrahi spoke about understanding microaggressions and that it has a lot to do with gender roles and she exemplifies by stating that it is generally socially accepted that a man might snap at home because he is the sole bread-winner.


Session on "Breaking the silence: Safeguarding women against sexual harassment in every sphere." on December 11, 2023
