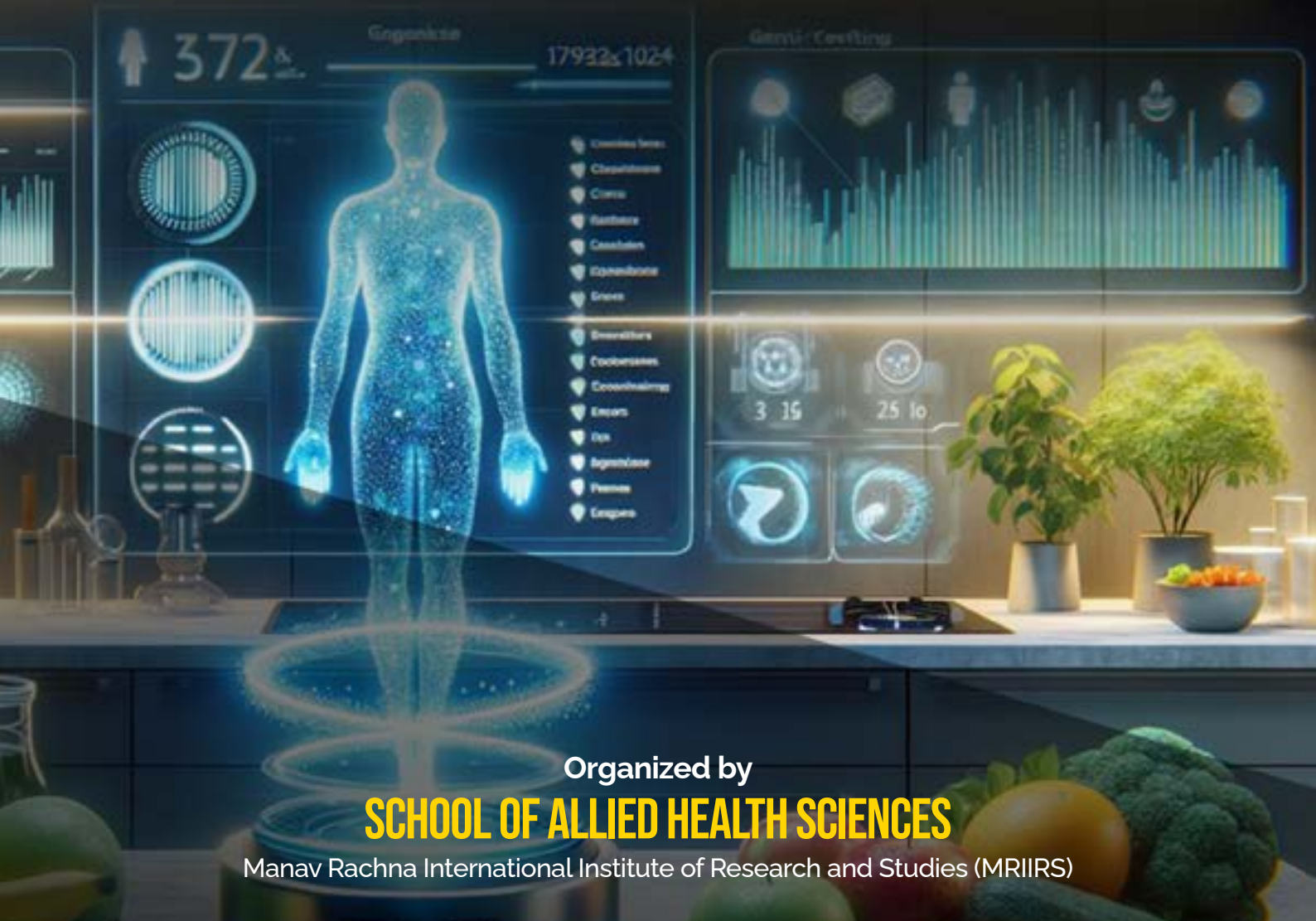

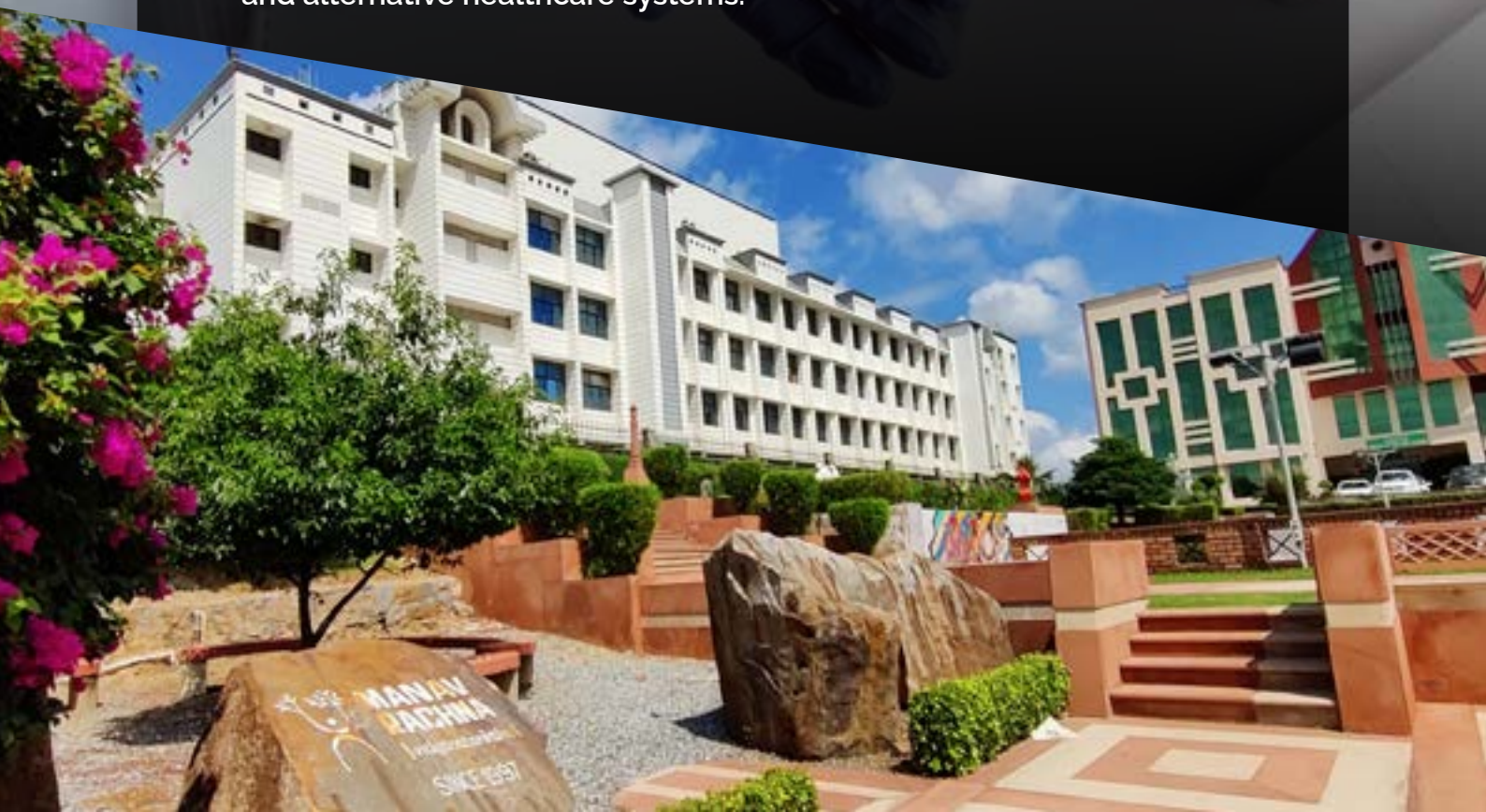

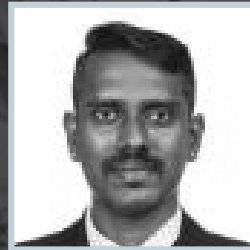

ABSTRACT SUBMISSION GUIDELINES

1. Abstract must be written in English.
2. Each Submission must be made electronically on <https://forms.gle/P2B6niv548PgyQVE8>
3. The submitting author must be the presenting author, as the correspondence will be with the submitting author.
4. Max. of 5 authors will be allowed in one abstract.
5. Each presenter can submit and present only two papers. They can be named on other papers as co-authors but as presenting authors on only two.
6. The certificate will be given to only the presenting author.
7. The body of the abstract is limited to 300 words. (Excluding the title and information of authors).

8. Abstract shall be submitted under the following headings:

Heading	Description
Title	Title of the study
Author	Names and affiliation
Background	Background information on the topic
Purpose	What was the reason for doing this research? Any secondary objectives
Methods/ Methodology	What methodological approach was used for the study, and the methods used for data collection and Analysis?
Results	Briefly summarise the main findings of the study
Conclusion	What can be concluded from the analysis of your data? what are the suggestions for future work
Implications	How does this study contribute to practice/ management/ education/ policy making etc?
Keywords	Use up to 3-5 words to describe your work which is supplementary to the topic

9. Abstracts can be submitted under the following subthemes (but not limited to):

- a. Nutrition, Immunology and Genetics
- b. Sustainable Food Systems
- c. Prevention and management of Non communicable health disorders
- d. Health and wellness
- e. Trends in Physiotherapy and Nutrition
- f. Holistic approaches: Yoga, Ayurveda, Traditional

10. The selected abstract's presenting author must be registered for the conference before January 10, 2025. If this fails, the abstract will be withdrawn. Selected abstracts will be published in an indexed journal.
