University has provided various modes for depositing the fees as per details given below:-

- > Payment Gateway from ERP. Please follow the following steps-

Enter your login (user ID and password)
Pay your fee through clicking on fee tab.
- > Cash payment at any of the branches of HDFC Bank Ltd in India through Pre-Printed Payment Challan. In this case, students are required to download Challan from their ERP portal and submit the same at HDFC along with the requisite fee. Convenience Charges @ Rs. 12 per transaction are payable to the Bank.
- > Through Credit Card at Campus, for which convenience charges @ 1 % are payable.
- > Through NEFT/RTGS both online and at any bank's branch. Details to be mentioned for NEFT transaction are given as below:-

Last date for depositing the fee is 30th April, 2024. Students who fail to deposit fee by 30th April 2024 shall be levied a fine in the following manner:-

S. No.	Point of Time of Late Fee	Fine Amount
1	1 st May,24 - 10 th May 24	Rs 100/- Per day
2	11 th May,24 - 20 th May,24	Rs 1,000 + Rs 300/- Per day
3	21 st May,24 - 30 th May,24	Rs 4,000/ + Rs 500/- Per day

After 30th day of last date of fee, name of the students shall be struck off from the roll and shall be registered on paying the re-registration charges of Rs 10,000/-
