The Anti Ragging Squad will conduct the enquiry observing a fair and transparent procedure and the principal of natural justice and after giving adequate opportunity to the student or students accused of ragging and

other witness to place it before the facts, documents and views concerning the incidents of ragging and considering such other relevant information. The squads shall work under the overall guidance of Anti Ragging Committee.
