It is also ordered that a Saving Bank Account will be opened in the name of **Youth Red Cross- Manav Rachna University** in which the subscription of Rs. 80/- per annum realized from the each student shall be deposited and further, shared between University, Indian Red Cross Society, Haryana and Youth Red Cross Wing of the University as per their share prescribed for the purpose. The account will be operated jointly by the Program Coordinator, Youth Red Cross-MRU and One of the members to be nominated by the Vice Chancellor.

An Executive Committee under the Chairmanship of Vice Chancellor shall also be constituted as per the composition prescribed in the guidliens to promote the Red Cross activities in the Institution.
