- 4. To deal with any other matter that may be referred to it by the Board of Management/Academic Council/Chancellor/Vice Chancellor.

5. A minimum seven days' notice of the meeting shall be given by the Chairperson. However, the notice for emergency meeting shall be three days. The Chairperson shall issue agenda and maintain minutes of the meeting.
