The following are the minutes of the meeting:

Registrar requested the Hon'ble Members to rise for National Anthem. After National Anthem, the Registrar welcomed all the members present in the meeting and requested the Vice Chancellor to open the meeting with his brief remarks.

12.1 Opening Remarks by the Chairman

The Vice Chancellor, at the outset, greeted the members present in the meeting. The Chairman then informed that:

- On the last date of admission (30-12-2019) of the admission session 2019-20, 637 admissions have been made this year. It includes the admissions through lateral entry and migration in all the programs as well. The total admission this year were 52 more than last year.
- This year 269 Graduands who have completed all the formalities, shall be awarded the degrees in the forthcoming convocation,.
- Institution Innovation Council, AICTE, North West Region has given 4 star rating to the Innovations Cell of Faculty of Engineering, Manav Rachna University which is among the 14 Institutions who have been given the 4 star rating. Total number of institutions who were awarded a rank were 143 institutions.
- Manav Rachna Center of Excellence on Alternate Dispute Resolution was inaugurated on 7th September 2019 by Hon'ble Minister of Law & Justice. First training session was organized on 26th September for LLM Students & Faculty Members and the resource persons were Advocate Mr. Ratan K Singh and Advocate AVS Subramanyam.
- Manav Rachna Centre for Peace and Sustainability was established and was inaugurated by Prof. Ved Prakash, Former Chairman, UGC on 4th October, 2019. On the inauguration date itself, a National Seminar on "Alternative Politics: Peace & Sustainability" was also organized which was attended by imminent persons, faculty and students. Various topics of discussion in the national seminar that were deliberated were:
 - Alternate Politics: Gandhian approach
 - Value Based Education and Peace and sustainability
 - Role of Women in bringing Peace



- The permission to commence B. Ed special Education (Learning Disability) for two Academic Session 2019-20 and 2020-21 was received after closure of admissions, from Rehabilitation Council of India which is the Regulatory Authority for the program. The program will now be offered from the next academic session.
- MoU has been signed with Sahai Research Labs, Gr. Noida, which will facilitate knowledge sharing activities directly from the Industry.
- A workshops cum trainings was organized for the faculty & student by the Departments of Physics on Raman's Spectroscopy. It was also attended by participants from other institutions.
- Department of Chemistry organized one day workshop on Good Lab Practices for faculty & students. It was conducted by Dr. Sangeeta Pandita from Zakir Hussain College, Delhi University.
- Department of Management & Commerce organized workshop on Entrepreneurship for the E&FB students which was conducted by Dr. Rita Sengupta from NIESBUD
- Department of ECE organized workshop for the class 11th & 12th students of Govt.
 Girls Senior Secondary School on Aurdino & Solar Technology on 18th September in the Incubation center of MRU.
- MRU Organised public lectures which were attended by a large number of persons even from outside the University, One of these was: "Kashmir Issues: the way forward" organized on 31st August, Dr. Aman Hingorani Senior Advocate of Supreme Court
- Blood Donation Camp was organized on 16th September in the memory of the Founder Dr. O P Bhalla. The students and faculty of the students participated with full enthusiasm which resulted in collection of 368 Units of blood by the lions club and Santo Kaa Gurudwara.
- 26 member delegations from Soka Gakkai International Japan interacted with Vice Chancellor, Faculty & students of the University and visited various facilities at the Campus.

The Chairman also mentioned about the various Achievements, Awards and Honours received by the Faculty and Student during the last 4 months. Some of these are:

• Dr. Aditya Sharma (assistant Prof. Physics) submitted the research Proposal to Pohang Accelerator Laboratory, South Korea and has been given permission for



testing and analyzing the samples at their lab in South Korea using "Beamtime for Synchrotron Accelerator-Based X-ray absorption spectroscopy technique". He shall also get Travel Grant (local and International) for pursuing his research work.

- Dr, Jaya Tuteja, Faculty of Chemistry has been selected for young early career researcher award under Newton Bhabha Fund of British Council.
- Faculty of Education & Humanities, developed MOOCs under OE4BW initiative by UNESCO.
- Dr. Manmeet Bali Nag, Faculty of Management & Commerce has been awarded with Prof. D S Kothari Chair by United Services Institution of India.
- Dr. Babita Parashar successfully completed the self-learning online course on "Understanding Open Educational Resources" offered by the commonwealth of Learning, Canada.

After these opening remarks, he requested the Registrar to take up the subsequent agenda of the Meeting.

12.2 Confirmation of the Minutes of the Eleventh Meeting of the Academic Council held on 23.07.2019.

Decision: Academic Council confirmed the Minutes.

Decision: The members appreciated the activities carried out by the university and took the said information on Record.

12.4 Action taken report on the decision taken in the 11th meeting of the Academic Council.

Action Taken Report on the decisions taken by the Academic Council in the last meeting was reported for information of the Hon'ble members and Council was pleased to note the action taken on previous decisions. On the query of Hon'ble Member, Prof. S. K. Garg with regard to MOOCs Courses at Point No. (8), it was informed that about 300 Students participated in the MOOCs' and were awarded "Ä" Certification.

Decision: Academic Council took the Action Taken Report on record.

12.5 Consideration and approval of the name of Graduands who pass out in the year 2019-20 for award of Degree in the forthcoming Convocation of the University.

It was submitted that University has to confer 269 Degrees during 3rd Convocation, to UG/PG Students who are duly qualified and have passed out in the year 2018-19. The same is to be held on December 06, 2019. As per the request received from the Examination Branch all such students whose list was presented, have completed all the statutory requirements as required under MRU Ordinances. The details regarding discipline wise Granduands were also placed before the Council with request to approve the same.

Decision: Academic Council approved the conferment of Degrees to 269 students who passed out in academic session 2018-19.

12.6 Approval of admissions made in all the UG/PG programs during the Academic Session 2019-20.

The Academic Council was informed that total 637 admissions to various UG/PG programs for the academic Session 2019-20, including admission through lateral entry and migration were made till 30.09.2019. It was also apprised that 02 students have withdrawn their admissions due to their personal reasons hence, total admissions in all the program is 635 at the moment. The program-wise details of total students, who took admission in various UG/PG Programs and on roll during the year 2019 were also provided to the members of the Academic Council. The members were requested to approve the same including the cases of 06 candidates granted special relaxation in eligibility condition.

Decision: Academic Council approved the admissions of all the above candidates admitted during the session 2019-20.



12.7 Consideration of Program Structure and syllabus of five year Law Honours Programs from 6th to 10th Semesters.

Academic Council was apprised that Program Structure and Syllabus for 1st to 4th Semester of the BA LLB (5 Years), BBA LLB (5 Years) & B.Com LLB (5 Years) were approved by the Council earlier. Further based on the proposal of Dept. of Law on the advice of Advisory Board the Program Structure and Syllabus of 6th to 10th Semester was presented. The same has been duly recommended by the Board of Studies of the Department which was placed for consideration of the Academic Council. The HoD of Law presented the salient features of the Program Structure and Syllabus of Integrated Law (H) Programs from 6th to 10th Semester and Program Structure and Syllabus of LLM (One Year) and LLM (Two Year) Program.

After the deliberations, Prof. Garg suggested some changes required to be made in the program structure and suggested that

- "Scheme and Syllabus" as mentioned on the cover page to be renamed as "Program of Study"
- The Program of studies should also includes the scheme of examination and evaluating.
- Grade awarded be replaced with Grade earned and aligned with Regulatory requirements.
- Hard and Soft Courses be duly explained and be renamed as per the scheme provided under guidelines of AICTE.
- The Grading pattern used for evaluation and award of grades be explicitly provided.

The above suggestions were taken note of and the HoD of the Department was advised to make the changes accordingly.

Decision: The Council approved the Program Structure and Syllabus of Integrated Law (H) Programs from 6th to 10th Semester and Program Structure and Syllabus of LLM (One Year) and LLM (Two Year) Program including the above suggestion and authorized Vice Chancellor to approve the same with suggested modifications.

12.8 Amendment in MRU (First) Ordinance, 2015 and proposed MRU (Third) Ordinance, 2018 by retaining Common provisions in the First Ordinance and framing Regulations concerning UG/PG/Ph.D. and PG Diploma programs leading to award of Bachelor / Master & Doctoral Degrees / PG Diploma etc.

Academic Council was informed that the First ordinance of the University which comprises the Academic Programs leading to award of degrees of Bachelor of Technology, Master of Technology, Master of Business Administration, Doctor Of

Philosophy, Post Graduate Diploma and Certificate Programs have been notified by the Directorate of Higher Education in Haryana Gazette Part-IV on Jan.08, 2019. Further, 3rd Ordinance which comprises the UG/PG Programs leading to award of Degree of Bachelor of Science, Master of Science, Bachelor of Education (Integrated), Bachelor of Education, Master of Arts in Education, Law (H) and Bachelor of Business Administration is also duly approved by the Academic Council and Board of Management has also been submitted to Directorate, Higher Education, Govt. of Haryana for approval and notification. On receipt of the recommendations from Department of Higher Education, in respect of Third Ordinance, it was felt that it contains provisions which change over short periods, as per the requirement of Industry, and becomes difficult to implement with minor modifications. It was felt that such provisions need to be made as regulations/guidelines which are subject to change from time to time depending upon the guidelines as issued by the Regulatory bodies. Therefore it is presented before the members for their approval so that University could think of splitting the same into ordinances and regulations.

Accordingly, a draft MRU (First) Ordinance, 2019 and MRU (Academic Program) Regulations 2019 covering UG / PG / PG-Diploma and Doctoral Programs leading to award of Degrees in such Programs offered till 2019-20 and a separate regulation relating to Conduct of Examinations, was placed before the Council for consideration and approval. It was also informed to the Members that the proposed Ordinance and Regulations for the Academic Programs shall replace the MRU (First) Ordinance, 2015 (already notified in the Gazette of Haryana and in force at the moment) and also draft MRU (Third) Ordinances, 2016, which is yet to be notified by the State Government.

The Hon'ble Members of the Council, after deliberation on the fresh Ordinance and Regulations suggested some modifications in some of the clauses so that these are in line with the guidelines of the Regulatory Bodies. It further authorized the Vice Chancellor to approve the same after incorporation of the suggestions made by the members. Vice Chancellor stated that before approval, he would like to circulate the same among the expert members for their opinion.

Decision: Academic Council authorized Vice Chancellor to approve the above Ordinance and Regulations and recommended for placing it in the Board.

12.9 Any other item with the permission of Chair.

(i) Consideration of Syllabus for the Courses to be offered as an elective offered across all the UG Programs.

The Dean, Faculty of Education and Humanities informed the members regarding the syllabus of courses (04 electives) to be offered across all the UG Program in collaboration with MR Centre of Peace and Sustainability, from the forthcoming semester / academic year. The 04 electives proposed to be offered are:



- (a) Essentials of peace and sustainability-I -(2-0-2-0)
- (b) Essentials of peace and sustainability-II -(2-0-2-0)
- (c) Essence of Indian Traditional Knowledge -(1-0-2-0)
- (d) School Leadership and management (EDS 236) -(1-0-2-0)

Besides, the Faculty of Education also proposed to offer a course on E-Learning as "CORE" to the students pursuing B.Ed. and Integrated B.Ed. program in collaboration with Centre of Peace and Sustainability.

The Council deliberated the proposed syllabus and suggested it is within the purview of BoS and accepted its recommendations.

Decision: Academic Council took on record the proposed syllabus of all the courses to be offered, the details of which are annexed as <u>Annexure-I</u> of the Minutes.

The Meeting ended by vote of thanks to the Chair.
