Following are the minutes of the meeting:

The Registrar welcomed all the members present in the meeting. He extended special welcome to Prof. Geeta Thakur, Professor, Education who attended the meeting as member of the Council for the first time and also expressed his gratitude to outgoing member Prof. A.K. Gupta, Ex Professor Chemistry for his valuable contribution during his stint as Member of the Academic Council. With these words, he requested the Vice Chancellor to open the meeting with his brief remarks.

#### **14.1 Opening Remarks by the Chairman**

Vice Chancellor greeted the members and said that during the period of pandemic, Manav Rachna University along-with imparting instructions online; also conducted/participated in various activities/organized events. These are:

##### **(A) University Related**

1. As per Times Engineering Survey, 2020, Manav Rachna University is declared among the Top 3 emerging Engineering Institutes of the country. It is also the topmost promising and emerging institute for Placement and Research Capability.
2. MRU also received the QS I-Gauge E-Lead Certification for its readiness to deliver online education in appreciation of the digital shift and readiness level of the University towards online education during the global pandemic on 31st May 2020.
3. MRU started with its classes for senior semesters on 26th May in online mode which was concluded on 11th September, 2020. All internal assessments, T1 & T2 were conducted properly and video proctoring was carried out during the Formal assessments using Google meet and University LMS system. End Term Exams are starting from 21st September.



4. All the practical sessions were conducted using Virtual Labs/Open Source Software /Simulation Software. For few Courses which have 40-60% Labs are to be conducted in physical manner in October by calling the students in batches and following the protocol prescribed for COVID-19.
5. Period from October to December will be utilized for students trainings, projects and research work and the New Academic session will start from Jan 2021.
6. Admissions for the Academic Session 2020-21 are currently going on and hope the after the declaration of results for JEE, NEET, etc. the same will pick up in coming weeks; and the university would be able to have more admissions in all the programs as expected.
7. For the Students admitted till now, Orientation Programme has started from 01.09.2020 under the guidance of Dean Academics and Dean, Students Welfare, where interaction with all the central teams like CDC, CRC and Dean Research was held and currently, students are undergoing the department specific orientation. Regular classes will start from 1st Oct.
8. A Memorandum of Understanding (MoU) was signed on January 14, between Manav Rachna University, Truechip Solutions Pvt. Ltd. and Future Tech Wizards LLP. Earlier it was for providing Support in terms of student's projects & Trainings but with the signing of this MoU, MRU will now offer specializations in VLSI & Health Care Technology to ECE students in collaboration with them.
9. Manav Rachna University is one of the 7th Institutes in India that have been selected by Amazon AWS Educate to deliver cloud computing curricula from the Amazon Web Services (AWS) Educate global initiative into its mainstream college syllabus to help develop the next generation of cloud professionals. The cloud computing content from AWS Educate will be offered as part of Bachelor of Technology (B. Tech) in Computer Science and Engineering program starting in October 2020.
10. Department of CST has signed MoU with Microsoft for Azure Skills University Engagement programme for its B.Tech. final year students for enhancing their employability skills.



11. Manav Rachna University (MRU) and ICT Academy (an initiative of Government of India) signed MoU that shall encompass Faculty Development, Skill Development, joint Research and Publications, Entrepreneurship Development, Digital Empowerment and a strong Industry Academia Interface.
12. Faculty of Law under its Centre of Excellence in Alternate Dispute Resolution conducted 21 Webinars in the area of Arbitration & Mediation during the lockdown period under the able leadership of Mr. Ajay Thomas, Director Law. More than 500 participants were benefitted.
13. Faculty of Law is also in the process of setting up Centre of Excellence in the area of Legislative Studies & Research. Mr. P K Malhotra, former Union Law Secretary to the Government of India has been appointed as the Executive Chairman of the Centre.
14. During this period, Under the Manav Rachna Center for Peace & Sustainability, seven webinars were organized. The resource person for the sessions were, Dr. Karan Singh, Dr. Rajender Shinde, B K Sister Shivani, Dr. Muzaffar Ahmed and recently by Rishi Vidhyadhar Ji from Art of Living.
15. Department of ECE, Mechanical, Education, Physics organized FDPs on latest technologies for their faculty as well as for other institutions.
16. During this period, faculty and students completed more than 700 certification courses on Coursera, Edx, Altair University, NPTEL Swayam and other MOOCs platform.

## **(B) Placements**

1. Placement process for 2020 Batch is still in progress. The department wise placement position is as follows:
  - (a) CSE - 110 students out of 131 eligible candidates place with EXTRAMARKS with Highest Salary Package: 12 LPA. (Average Salary Package: 3.5 LPA)
  - (b) ECE - 15 students out of 22 eligible candidates placed with LIDO LEARNING. Highest Salary Package: 10 LPA, Average Salary Package: 3.9 LPA.





- (c) ME – 19 students out of 38 eligible candidates placed with SONALIKA INTERNATIONAL TRACTORS. Highest Salary Package: 5.5 LPA, Average Salary Package: 3 LPA
- (d) Chemistry, BBA & Education- 8 Students were also placed with Jubilant Chemisys and Wipro with average a salary Package of 3.5 LPA.
- (e) Placement process for Engineering Batch 2021 also has initiated, some students have already been placed, 44 students are shortlisted for Capgemini and the final results are yet to be declared.

## **14.2 Confirmation of the Minutes of the 13th Meeting of the Academic Council held on 21.04.2020.**

Hon'ble Members of the Council were informed that Minutes of the Thirteenth Meeting of the Academic Council, held on 21.04.2020, were circulated to all the members through email on 05.05.2020, no comments were received from any member. Copy of the Minutes was shared in the meeting with the request to kindly confirm the Minutes.

Hon'ble Members were informed that the Council, in its last meeting had considered the draft guidelines on formation of Institutional Human & Animal Ethics Committee (IHAEC) and Institutional Lab Safety Committee (ILSC), as per requirement prescribed for NAAC accreditation. The Guidelines has been prepared afresh incorporating the suggestions/inputs from the members and circulated among the members through e mail. On being okayed by the Members, it was approved by the Vice Chancellor.



**(x) Commencement of III, V & VII Semesters (2020-21) from 26.05.2020.**

It was submitted for information that Odd semesters online commenced from 26th May, 2020 instead of 21.05.2020 as reported in the last meeting of the Council.

**(xi) Commencement of classes for 1st Semester (new academic session) 2020-21 from 01.10.2020**

Academic Council was informed that the admissions for the Academic Session 2020-21 in all the UG & PG are in progress. However, keeping in view the guidelines received from the regulatory bodies, it is decided by the university to start the classes for UG & PG programs (I semester) session 2020-21 online from 01.10.2020 onwards. However, two weeks orientation program which shall be followed by the two weeks departmental activities has already been started from 1.9.2020.

**(xii) Extension of Approval by the AICTE for ongoing engineering programs for the session 2020-21**

It is informed that AICTE vide its letter dated 30.04.2020 has granted extension of approval for ongoing UG programs offered under the Faculty of Engineering for the Session 2020-21.

**Decision: Academic Council took the above information (i) to (xii) on record.**

**14.4 Matter for ratification**

**(i) Bringing the eligibility criteria for B.Ed. Special Education (LD) at par with the one prescribed by the RCI for the session 2020-21.**

It was submitted that the Council in its 11<sup>th</sup> meeting held on 23.07.2019 had approved the eligibility criteria for admission to the program as 60% aggregate in Graduation/Post Graduation. In order to attract more candidates in the present pandemic situation, university in consultation with the Dean of the Faculty has decided to bring it at par with the one prescribed by the RCI for the



program. Accordingly, it is now made 50% in aggregate at Graduation/Post graduation level with the approval of the Competent Authority. The Council is requested to ratify the action of the University.

**Decision: Academic Council ratified the above action of the University.**

#### **14.5 Action taken report on the decision taken in the 13th meeting of the Academic Council.**

Hon'ble members were apprised about the action taken on the decisions and were requested to take it on record.

**Decision: Academic Council showed satisfaction about the Action Taken on decisions of 13th meeting and took the same on record.**

#### **14.6 Consideration of IT Policy.**

There are different categories of users in the University. Therefore keeping in view their requirements and portfolio, different policies are being implied based on the category of the users such as, Faculty, Staff (general / management/ support) security and students. All the category of users uses computers and internet through local area network. Therefore the network, the devices, the databases, the files created by the users are vulnerable to then risk of losing the data, damage of the devices, stealing of important information etc. These threats, do arrives from different sources viz. infected device and files bringing by the users, virus infection through unlicensed and untested applications, through emails, through browsing non- secured web sites, phishing internet web sites and finally hackers.

Thus, to secure the data and devices through strong policy driven user accesses and segregating the infrastructure is the virtual and logical way. The segregation also needs to have provision of users communicating to each other, exchanging files, exchanging emails etc. Therefore, to prevent such threats and to build a strong IT infrastructure, a draft IT Policy prepared by the IT department was presented before the Council for consideration and adoption in the university. The Council after deliberation recommended for adoption of the same by the University.

**Decision: Academic Council recommended for adoption of the policy with approval of the Board of Management.**

#### **14.7 Consideration of Policies on IPR and Business Incubation.**

It was submitted for information that the policies on IPR and Business Incubation were approved by the Academic Council in the fifth meeting but, keeping in view





the national policy on the subject, a need was felt to review them and incorporate the provisions in line with the national Innovation and Start-up Policy issued by AICTE on September 11, 2019 and model IPR policy of CIPAM 2019.. Therefore, a Committee under the chairmanship of the Dean Research was constituted to review the existing policies on IPR and Start-ups / Business Incubation. The Committee has come out with the fresh policy documents. The new Policies shall repeal the existing policies and shall come in force from the date of the approval of the Board of management.

Dean research was requested to apprise the Council with the changes proposed in the new policy documents. He explained the salient points which are included in the new documents to the members. After detailed discussion, it was okayed by the Council with recommendation that it be placed before the board for approval.

**Decision: Academic Council okayed the new Policy on IPR and Business Incubation and recommended that the same be placed for approval of the Board of management.**

#### **14.8 Consideration of amendment in policy relating to Additional Internship/ Start-up/Innovation/Exchange Programme to other organization for Graduate programme**

The Council was apprised that the above policy was approved by the Board of Management on 15 .01.2020 as it was to be implemented immediately. The policy is revisited by a committee headed by the Dean Research which has now suggested some minor amendments in the form of additions/substitutions in the above policy which are produced as under:

Dean Research explained in brief the needs for changes and explained in detail for information of the members. On the point of credit relaxation raised by one of the members, it was clarified by the Dean that credits relaxation is already mentioned in the table for UG degree so there is no need of any change but suggestion of Prof. S K Garg to include CGPA condition for Hons. Degree was





agreed and it was advised to incorporate CGPA conditions in University regulations. With this suggestion, It was okayed by the Council with recommendation to place the same before the BOM for approval.

**Decision: Academic Council consented the proposed amendments in the above policy and recommended that the same be placed before the Board of Management for their approval.**

#### **14.9 Program Structure for the Honours Programs in 7th to 10th semester of BALLB, BBALLB and B.Com LLB**

Academic Council was informed that the program structure for the above programs from 7th to 10th semester was approved by it on 02.12.2019. Now, on request of the students; the department has proposed to offer two streams of specializations, one in Corporate Law and another in Criminal Law for the batch of 2017. Out of 80 students, 20 students opted for corporate law and 19 for criminal law. The program structure of honors courses in Corporate Law and Criminal Law which are agreed by the Bos of the Department was presented for consideration of the Council. HoD law explained in detail the salient changes/additions which were agreed by the council.

**Decision: Academic council approved the same. Detailed Program for 7<sup>th</sup> to 10<sup>th</sup> Semester of B.A. LLB, BBA LLB and B.Com LLB is placed annexed as Annexure-I.**

#### **14.12 Consideration of Varied Methods of Assessment for PG programs**

The Council was apprised that the Department of Law wants to introduce Learner-centric Choice based Assessment Methods at PG level, wherein students may make choice from amongst the varied methods not only for internal assessment but also for the end-term assessment, including Essay writing, Project Report writing, Response Paper, Take Home Assignments, Published article, Case Briefs/ Legal Briefs, Concept Map, teaching assignments, Annotated Bibliography, Abstract writing, case comments, Case Review, book review, drafting civil or criminal petitions or written statements and such similar such assignments.

It is also proposed by the department to allow for taking open book/ take-home/ 24-hour assignment for T3 examination, with the approval of Board of Studies of the department.

The proposal was deliberated at length. It was appreciated but members were of the view that all the options need not be opened at one go, initially four or five options be chosen and tested about its applicability and implementation in a proper manner and then other options be considered for offer to the students.

**Decision: Academic council approved the proposal with the advice that not more than five options be initially offered to the students of LLM.**
