The following are the minutes of the meeting:

4.1 Opening remarks by the Chairman

The Chairman welcomed all the members present in the meeting and mentioned that after the initial challenges, the University has come up well. With the addition of Two new Faculties i.e. Faculty of Education and Faculty of Law which would offer the Bachelor of Education, M.A in Education and Bachelor of Laws programs respectively from the ensuing academic session 2017-18, we are expecting increase in number of admissions during the year 2017-18. Recently concluded MRNAT-2017 (First phase) is an indicator to that. The B.Ed. program has been getting good response but the response to the integrated B.Ed. programs is lukewarm on two counts; one being a new discipline and other lack of awareness among the masses. The Chairman also mentioned that our focus towards MA Education program has not been up to desired level, there is need to give attention to this program as well which would definitely of an advantage to the Dept. of Education.

He further said that the students were doing well, overall achievements of the University have been found to be up to an acceptable level. The new faculty members who have joined the above two faculties are having impressive records and possess expertise in their areas. Prof. Jose Varghese who has been Former Vice Chancellor, Hidayattullah National Law University, has joined as an Emeritus Professor in the Dept. of law. He further said that, due to efforts of the faculty and officers, the University has been able to conduct examinations and declare results well in time. He further talked about the ongoing research work carried out by the Departments and stated that with the formation of the Research Clusters and focus on it, the University would be able to do much on this front. With these words, he concluded his remarks and requested the Registrar to carry out the proceedings. The Registrar then took up the agenda of the meeting one by one as follows;
