- Receive the complaints in writing from the concerned students.
- Examine the matter in detail on the basis of available documents.
- Recommend to the Chairperson to forward the matter to the Station House Office (SHO) if there is any merit in the matter.
- Recommend to the Chairperson to initiate disciplinary action against the culprit.

Any student found guilty of Ragging on College Campus is liable to one or more of the following punishments:

- Suspension from the College.
- Debarring from appearing in Internal and University Examinations.
- Cancellation of Admission and compulsory Transfer Certificate.
- Any punishment or fine awarded by the Legal Authority.
