

In continuation to this Ministry's letter of even number dated 20.3.2013 & 30.3.2013, I am directed to convey the approval of Central Government for renewal of permission for **3<sup>rd</sup> year MDS** course in the specialities of (i) Periodontology with 3 seats (ii) Oral Medicine & Radiology with 3 seats (iii) Orthodontics & Dentofacial Orthopedics with 3 seats (iv) Conservative Dentistry and Endodontics with 3 seats (v) Prostodontics and Crown & Bridge with 3 seats (vi) Paedodontics and Preventive Dentistry with 3 seats (vii) Oral Pathology & Microbiology with 3 seats, for **2<sup>nd</sup> year P.G Diploma** course in the specialities of (i) Orthodontics & Dentofacial Orthopedics with 1 seats (ii) Conservative Dentistry and Endodontics with 1 seat and for grant of permission for **starting of PG Diploma** Course in the speciality of Prostodontics and Crown & Bridge with 1 seat at Manav Rachna Dental College, Faridabad for the academic session 2014-15. The permission for starting of PG diploma course in the speciality of Prostodontics and Crown & Bridge with 1 seat is granted for the year 2014-15, since the college authorities has not admitted the students in the year 2013-14.

2. The admission in next batch of students in MDS/PG Diploma Course in the above specialities for the academic year 2015-16 will be made only after recognition/renewal of permission in MDS /PG diploma course the Central Government.
3. *In case any admissions are made in violation of the above condition, the same will be treated as irregular and action under Section 10B of the dentists (Amendment) Act, 1993 will be initiated.*
4. Discrepancies, if any, may be brought to the Notice of DCI and State / Central Government.


