UNDERTAKING BY THE STUDENT FOR THE HOSTEL FACILITY

I, _____ S/o, D/o _____ resident of, solemnly affirm & undertake that:

1. I am a student of _____ (Course) _____ (Institute) _____ enrolled as roll no. _____
2. I shall abide by the provisions of the university ordinances, Rules, Orders, Instructions, Circulars etc in force and as amended from time to time (Hereafter jointly referred to as “the Provision”) framed by the university including rules of the hostel and concerned authorities ,officers, warden and staff (hereinafter referred to as “the University”)
3. The University shall be at liberty to impose any penalty and/or any disciplinary action on me being found guilty of any sort of misconduct or indiscipline or disobedience or malpractice within or outside the premises of the University, including hostel and any act which is detrimental to the interest of the University / Hostel and / or make breach of any of the “ provision” of the University In the aforesaid event ,the University may discontinue my stay in the University and or hostel and I shall not be entitled for any refund of admission fee, bus and any other fee/charges paid to the University and I shall also be liable to pay the pending fee, due, penalty, etc.
4. I shall retain the hostel accommodation for the full academic session (i.e. one year), due to any reason I leave the hostel during academic session (i.e. one year), I shall pay the hostel charges for full academic year.
5. I am aware that ragging is a criminal offence and is strictly prohibited. I shall not indulge directly or indirectly in any act of ragging on the campus, inside premises of hostel or outside of the campus of the University, In case, I indulge either directly or indirectly in ragging, The University may take appropriate disciplinary action (including suspension/ expulsion from the hostel and/or the university) against me ; further legal action as per the law of land.
6. I shall not possess, use or deal with any kind of intoxicating materials including alcohol, drugs of any kind, gutka, tobacco, cigarettes, or any other sedative materials. In case I am found guilty of possessing the aforesaid material, the University may take any disciplinary action including suspension/expulsion against me.
7. I shall not possess, use or abet the use of any kind of weapons including sticks, rods, explosives, firework or any such materials. On being found guilty, the university may take any disciplinary action including suspension/expulsion against me.
8. I shall be liable to pay damage caused by me to the property of the university and other instruction on the campus including the premises of hostel, either alone or jointly with others and shall be liable to face disciplinary action initiated against me by the university.
9. I shall strictly adhere to the timings and rules as laid down for the hostellers, in default of which, the university may take any disciplinary action including suspension/expulsion against me.
10. I understand that I shall have to vacate the hostel in case of any requirement of the university for some specific period for any reason including accommodation guests, delegates, participants of any event, for maintenance work etc.
11. The university may inspect the room, bags, almirah or any of the personal belonging at any time.
12. I understand that hostel accommodation allotted at the time of admission or otherwise, may be shifted to other hostel, at any time and allotted room, floor and other facilities in the hostel may also be changed at any time as, decided by the University.
13. I shall not allow any unauthorized person to enter or stay in any room.
14. I shall myself take precaution against insect-bites, dog-bites, snake-bites, animal-bites and such other infections and diseases and shall carry the first-aid kits every time and the university shall not be liable for such infection and diseases.
15. I shall not misuse electricity by using electrical gadgets like irons, heaters, audio players, juicers etc.

I understand that in case I am declared ineligible for appearing in any examination of the University, on account of shortage of attendance or any other reason whatsoever or if ordered by the University authorities at any time for any reason whatsoever, I shall vacate the hostel immediately. Readmission to the hostel in the forthcoming term/semester may be allowed only at the sole discretion of the University.
17. All type of charges and fees as charged by the University are subject to revision from time to time.
18. I understand that for any unforeseen issues arising of that are not covered by this undertaking or in respect of all matters, not expressly provided herein, the University decision shall be final and binding on me and all other concerned.
